Councillor Gillis reported for fire. Calls included 2 medical, 1 structural, 1 motor vehicle collision, 1 water rescue, 1 motor cycle, 1 flu fire and 1 mutual aid.

Councillor Curtis reported on police. The report was distributed. Councillor Curtis reported an ongoing problem with four wheelers and he is working on this with Constable Dexter. The RCMP member felt opening trails to multi purpose use would fix the problem and yield right of way to bicycles and pedestrians. The RCMP member said there will always be problems.

Councillor Pottier had nothing to report for tourism and property.

Councillor Cahill reported for streets. There were 2 tenders for street paving for a section of Argyle Street.
